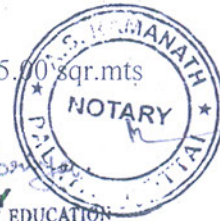
AFFIDAVIT

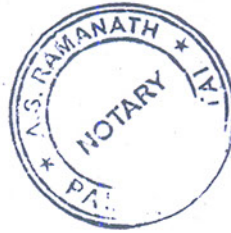
